He has also practised extensively in a wide range of matters concerning trusts, wills and estates and regularly represents parties in Inheritance Act matters. Leo appeared as counsel for the successful defendant in the most recent Inheritance Act case to be heard by the High Court of Australia, *Vigolo v Bostin* (2005) 221 CLR 191.

More recently he appeared for the successful plaintiff (appellant) before the Western Australian Court of Appeal in *Butcher v Craig* [2010] WASCA 92.
