**Topic:** The "Alhamrani litigation", Jersey's largest trusts case.

In keeping with STEP Perth's desire to deliver educational events not otherwise available in Perth, we present a seminar presentation by **Victor Joffe QC**.

Victor has been "in silk" for nearly 9 years at Searle Court, London. His main areas of practice are company, insolvency, commercial, civil fraud and international trusts (with a focus on high value cases in the Caribbean and the Channel Islands).

This seminar will focus on Jersey's largest ever trusts case, the "Alhamrani litigation". Victor acted for the plaintiffs in the litigation which involved a \$120m breach of trust. The principal defence in the litigation was that the beneficiaries knew of, concurred in and acquiesced in the breach of trust. Although the litigation settled, Victor will discuss the issues raised in the litigation, including whether the appointment of a new trustee was affected by the beneficiaries' knowledge.

While this case is from a foreign jurisdiction, it should be of particular interest to STEP Perth members and friends as the principal authorities are Australian.
